2. What personal data does Q8 collect?

3. Why does Q8 collect your data?

4. Who has access to your data?

If a participant in the contest has submitted a complaint within the period specified in the contest rules, the personal data will be retained until the final resolution of that complaint.

6. What are your rights?

- Correct their data if needed,
- Transfer their data.

Additionally, participants can request free restriction of processing in certain circumstances or object to processing based on our legitimate interest.

You can also object at any time to the processing of your data for direct marketing purposes. However, this withdrawal will not affect the lawfulness of processing carried out prior to the withdrawal or based on another legal basis.
